The Good and The Evil

People on earth have known since time immemorial what is good and evil, but the question has always been whether they really knew and understood this in every respect. And so, the question arises whether people today are actually aware of what they mean by good and evil. However, for many people this is extremely questionable. When you consider all the atrocities that people cause and commit, such as wars, horrific misery and distress through crime, jealousy, strife, lovelessness, hatred and interpersonal indifference, as well as through terrorism, murder, manslaughter, torture and the death penalty, through lies, fraud and dishonesty, etc., then it is actually questionable whether knowledge and understanding of good and evil still exists at all.

And the majority of humanity on earth is completely indifferent to this, because none of it concerns themselves, but unknown others. In addition, the majority of humanity greedily absorbs and devours all this injustice, everything evil, negative, bad and degenerate that is read, heard and seen, because it has somehow become a roaringly disgusting meaning of life, and as a result hardly anyone is interested in love, goodness, peace, balance and harmony anymore. Under the guise of democracy, power-hungry people, warmongers, and even despots and tyrants are brought to political power in governments who do not shy away from having the state carry out torture and the death penalty as well as warlike and murderous secret service and military operations, which result in the murder of countless innocent people. And all over the world, criminal organizations are kidnapping, selling and treating people as slaves, more than 42 million of them worldwide. Millions more live as otherwise oppressed people, and the majority of humanity on earth is completely indifferent to them too. Either empty words are simply thrashed out for them, or profit is made from them, namely through sex acts that can be bought or raped, even murder, or through the purchase of goods and products that are produced





by slaves and oppressed people - children and adults alike - and that end up on the world market. Entire populations of third world countries are systematically exploited, by their own despots and tyrants who act as rulers, as well as by companies and corporations from industrialized countries, where people sit quietly and majestically at overcrowded tables and fill their bellies with all kinds of good food and drink.

Of course, every intelligent and rational person knows what is good and evil if they only align, treat and nurture their thoughts and feelings correctly, and in this way everyone knows that despotism, tyranny and any other negative power is inherently evil, but nevertheless everything in this regard is accepted without hesitation. The reason for this is not far to seek, however, because the acceptance of power as evil is based on the false and negative thoughts and feelings of people who covet their own evil power and do everything to strive for it and to be able to realize it. So, people basically know very well what evil and negative power are, but they accept that both are exercised over themselves and over their fellow human beings, and only because they themselves want to exercise evil and power over others. At least that is the case for countless people in the majority of earthly humanity. However, there are many who want neither evil nor power, which is also evil in itself, but nevertheless in the majority of the entire human mass there is only a minority, a minority who live according to their good or best ability and do a lot of good, but unfortunately this cannot persuade the majority to turn to the better and the good.

The good and evil also include the progress in living standards, technology and science, which people are generally fascinated by and have become completely dependent on. However, if everything is examined closely in this regard, then, along with the good, there is also a great deal of evil, because everything contains death and destruction. The high standard of living alone is built on a murderous waste of people who are heavily contaminated by poisons in the production of food - as well as in the gardening and cultivation of fruit, vegetables and herbs - and who thus waste away and die miserably. This is quite apart from the fact that children and adults have to do slave labor under inhumane conditions and are paid miserably for it - if at all. And it goes without saying that science and technology also have a hand in this in some form, in addition to the fact that they bring death and destruction in some ways, for example through exhaust emissions and other environmental poisoning, through wars and terror as a result of the use of technical and scientific achievements.

Since time immemorial, man has never been encouraged to make the earth fertile and subjugated through evil, misery, need and destruction, because quite the opposite has always been taught: that he should regard it as his partner and protect it, look after it and never overpopulate it. Only religions and sects have always preached that man should subjugate the earth and go there to reproduce on a massive scale, and as a result, a situation has arisen that is already dangerous and hostile to life for the planet and all of nature,





as well as for human and all other existence. So, man has gone and started to destroy the earth, the climate and nature; has already eradicated hundreds or even thousands of animal and beastly life forms and is now in the process of depriving himself of all means of subsistence and wiping himself out through the ever-increasing overpopulation.

The people of the earth are living more and more far away from all the Creative-Natural Laws and Recommendations, the existence of which they have long since forgotten and which they have lost the ability to perceive. It has long since come to the point where honest helpfulness and real love of one's neighbor are insulted and denounced as 'buying one's neighbor', or that a person must expect that if he gives up his possessions in order to do good with them and help the poor, he will be called to account and patronized, if not thrown into a mental institution.

The truth is: Man is not evil in his creative-natural inner being, so he is not evil from his youth, but he develops into evil through his thoughts and feelings, from which corresponding attitudes and behaviors arise. And the emergence of these is usually due to the influences of upbringing and the environment. Man is therefore made evil on the one hand by external human influences and on the other hand by himself or his own thoughts and feelings. Family, acquaintances, the environment, as well as school, economic, social and political as well as religious-sectarian influences all play a decisive role. It is therefore necessary that these conditions be changed, and that this should be done by those people who still perceive the creative-natural laws and commandments and can implement them. It is their duty to correctly instruct the majority of those who are averse to good and who tend towards evil. But these cannot be changed by words and punishments, because they can only make a change for the better and implement it for the good themselves.





Well, the good and evil in people is a topic that is practically as old as humanity itself, since it has achieved reason and understanding. And it is also a fact that people cannot be changed in any of their behavior or attitudes, because only they can do this for themselves. So, everyone has to change for the better and carry within themselves the principle of hope that they can and will do this. There are no binding recipes for this, because as individual as people are in and of themselves, each of their approaches to themselves and their self-development and self-realization is also individual. Basically, only suggestions and advice can be given with regard to all or part of human behavior by trying to make people understand that they themselves have to learn to decide between good and evil in order to bring out only the good and positive.

It must also be made clear that the tension between good and evil in human behavior, in the community and in social structures must be thought through and made clear in order to understand the whole thing. It is also essential for people to explore, examine and learn to understand their relationship to themselves, because only when this is made visible can a truly conscious effort and understanding take place of how questionable evil ultimately and actually is.

Evil must never happen by itself, but the insight must prevail that in the end only good always comes out and everything is stimulated in a good way, because only the good and positive in life actually brings benefit and evolutionary progress. The fact is, however, that people constantly live in a field of tension between good and evil, although they themselves decide which side they want to turn to. Basically, they have free will, which means they can determine everything themselves and also shape their own thoughts and feelings as well as their attitudes, opinions, actions, deeds and behavior. This is his creative-natural right, which he has been given in this regard, and by which he decides for himself without exception what he wants to do and not do, and what he wants to continue doing or give up.

There is no doubt that people today are confronted with questions and problems every day, often every hour and even every minute, which often make it very difficult for them to recognize the boundary between good and evil, but nevertheless they must make an effort to recognize the boundary in each individual case. This is a safety line, so to speak, which must be recognized and not crossed, even if it appears difficult to recognize, unclear and confused or indefinable. If, however, vigilant attention and perception are cultivated, then a corresponding personal opinion on the matter can be given for every question and every problem, and the exact boundary between good and evil can be recognized and determined. And if we act attentively in this way, then, despite complicated questions and problems and despite all the degenerate and frightening things that are happening in the world, we can decide between good and evil and find the boundary between them. And the fact is that not only evil rules the world and mankind, but that good is also always present, happening and working in millions of ways. The voice of evil is always screaming very





loudly all around, but if you pay attention to what is also moving in silence, then despite all the negative and evil degenerates, you will still notice a lot of good, even if the good very often only works in a quiet way.

This quiet way of doing good, however, requires the complete silence of good and positive thoughts and feelings, because only when these can be cultivated calmly and quietly can the effectively good and positive be perceived, recognized, understood and implemented by people. This also means that people must recognize themselves, including the good, bright, and valuable as well as the evil, dark and instinctive within themselves. Because only when they make an effort to do this and also carry it out can they get everything under control and actually do the good that they really want.
